1. INTRODUCTION

The RSKA initiated KABADDI LEAGUE FOR MEN aims at strengthening the entire Kabaddi ecosystem to promote the twin objectives of mass participation and promotion of excellence in Kabaddi, particularly Senior Men. It has been introduced to strengthen Kabaddi culture in Rajasthan at the grass-root level by building a framework for Kabaddi, a sport of Indian origin.

RSKA KABADDI LEAGUE FOR MEN

With sports being an extremely important component for development in Rajasthan, RSKA aims to create the league as a self-sustaining model of excellence. A step ahead to this long-term aim can be achieved with the continuous support from corporate and businesses.

The RSKA invites only partners interested to run the KABADDI LEAGUE FOR MEN at least for ten editions of the event spread over 10 years. With the intent to renew the contract at the end of every 10 year period with a priority offered to the current owner of the league. If Winning bidder of this tender does not intend to continue at the end of any ten year period then a fresh tender can be floated by the RSKA.

The rights to run the mens kabaddi league will not be withdrawn by RSKA under any circumstances other than if the winning bidder is legally disqualified to being a going concern

From the perspective of companies and businesses; the prospective sponsors, it can also help them reach the target audience / customer group with additional benefits of garnering goodwill to their brand names. It provides a competitive edge that goes beyond product and price.

3. ELIGIBILITY CRITERIA

This is a BID floated to grant the Ownership and Organisation Rights which include and is not limited to Sponsorship Rights and Media Rights including Social Media against a Royalty Payment to RSKA for any eligible Individual or Firm or Company with sound financial background.

4. BID SECURITY / EARNEST MONEY DEPOSIT (EMD)

- 4.1 The Bidder shall furnish along with its Bid, Bid Security for an amount of INR 100,000.00 (Rupees One Lakh only)
- 4.2 The Bid Security is required to protect RSKA against the risk of the Bidder's unwarranted conduct as amplified under subsequent sections below. Non-submission of bid security will be considered as major deviation. Bid for the project without Bid Security will not be considered.
- 4.3 Bid security must be submitted to RSKA along with the bid.
- 4.4 The Bid Security shall be furnished in one of the following forms:
- a. Account Payee Demand Draft
- b. Banker's cheque

- 4.5 Demand Draft / Bankers Cheque from scheduled commercial bank drawn in favour of "Rajasthan State Kabaddi Association" payable at JAIPUR (Rajasthan) should accompany the Bid.
- 4.6 The Bid Security will be refunded to unsuccessful Bidders without interest within 30 days from the date of opening of the bid.
- 4.7 The EMD can be forfeited if an Winning Bidder:
- a. Withdraws or amends or impairs or derogates its bid during the period of bid validity.
- b. Fails to accept orders issued in its favour for execution, and / or violates the terms and conditions of the contract after submission of the bid.
- c. Successfully gets qualified, but fails to sign the contract within the stipulated time.

d. Without prejudice to other rights of RSKA, if it fails to furnish the required Performance Security within the specified period.

5. BID VALIDITY

- 5.1 The Bid is for one event of RSKA KABADDI LEAGUE FOR MEN to be conducted in FY 2022-2023 as per mutually agreed dates between the successful bidder and RSKA.
- The venue will be decided on mutually agreed Place and venue between the successful bidder and RSKA. Approximate days of the event will be 20 to 35 days. Tentative teams will be 8 each team comprising of 14 players + 1 Coach + 1 manager totaling 16 persons in all. Approximate matches should be 50-100.

6. SIGNING OF BID

6.1 Bid shall be typed and the same shall be signed by the bidder or by a person(s) who has been duly authorized to sign by his/her firm or company. A resolution of such intent be attached to the bid form CLARIFICATION OF BID

7. INSTRUCTIONS TO APPLICANTS

7.1 Proposal preparation cost

- The Applicants shall bear all costs associated with the preparation and submission of the Proposal. RSKA will not be responsible and liable for any costs, regardless of the conduct or outcome of the Proposal/process.
- All papers submitted with the Proposal are neither returnable nor claimable.

7.2 Right to accept and reject any or all the Proposals

- Notwithstanding anything contained in this BID, RSKA reserves the right to accept or reject any Proposal and to annul the bidding process and reject all the Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, without assigning any reason
- RSKA reserves the right to reject any Proposal if:
- At any time, a material misrepresentation is made or discovered, or
- The Applicant does not adhere to the formats provided in the Annexure(s) to the BID while furnishing the required information / details.

7.3 Data identification and collection

- It is desirable that the Applicants submit their Proposal after verifying the availability of the data, information and/or any other matter considered relevant.
- It would be deemed that by submitting the Proposal, the Applicant has:
- Made a complete and careful examination and accepted the BID in totality;
- Made a complete and careful examination of the various aspects of the Scope of Work.
- RSKA shall not be liable for any mistake or error on the part of the Applicant in respect of the above.

Preparation and submission of Proposals

7.4 Language and currency

- The Proposal and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by the Applicants with the Proposal may be in any other language provided that they are accompanied by appropriate translations of the pertinent passages in the English language. Supporting materials, which are not translated into English, may not be considered for evaluation. For the purpose of interpretation and evaluation of the Proposal, the English language translation shall prevail.
- The currency for the purpose of the Proposal shall be the Indian National Rupee (INR).
- Applicants should provide all the information as per the BID and in the specified formats. RSKA reserves the right to reject any Proposal that is not in the specified formats.
- In case the Applicants intends to provide additional information for which specified space in the given format is not sufficient, it can be furnished in duly stamped and signed.

7.5 **Submission of bid/Proposal**

• The Bid / Proposal with all documents should be sent by post or by Hand so as to reach RSKA Office – 2, Aakanksha, Ajmer Road, Jaipur – 302 021 on or before last date and time. Bids received late will not be entertained.

7.6 Withdrawal and resubmission of Proposal

- At any point of time, an Applicant can withdraw his / her Proposal submitted before the Proposal Due Date By informing RSKA in writing.
- From the time the Proposals are opened to the time the contract is awarded, if any Applicant wishes to contact the RSKA, on any matter related to their Proposal it should do so in writing. Any effort by the Applicants to influence any officer or bearer of the RSKA in the Proposal evaluation or contract award decisions may result in the rejection of the Applicant's Proposal.

7.7 Opening of Proposals

• RSKA will open all bids / Proposals, in the presence of Applicant's representatives who choose to attend on the prescribed date of opening at the RSKA office. The Applicant's representatives who are present shall sign a register evidencing their attendance. In the event of the specified date bid / Proposal opening being declared a holiday for the RSKA, the bids shall be opened at the appointed time and place on the next working day. Working day means the day when the office opens after the holiday for routine work.

8. AWARD OF CONTRACT

• RSKA reserves the right to accept / reject a bid, to cancel / abort the BID process and / or reject all bids at any time prior to award of contract, without thereby incurring any liability to the empanelled Page 6 of 14

agencies on the grounds of such actions taken by RSKA.

 RSKA shall award Contract to the best long term partner with commitment to create a long term successful and sustainable Men's Kabaddi League in Rajasthan.

9. PERFORMANCE SECURITY

The Successful bidder will deposit 50% of the Bid Amount within 15 working days to RSKA by way of Demand Draft / Bankers Cheque or RTGS failing which the EMD of the Bidder will be forfeited.

10. INTELLECTUAL PROPERTY

The bidder must ensure that all intellectual property of RSKA including but not limited to RSKA logo, creative's any work, brand name, trade name, service mark, trademark etc., related to RSKA shall belong to RSKA. In no event, the Winning Bidder shall, either directly or indirectly, register, file or attempt to register or file any such intellectual property in its own name.

The winning bidder may name the Mens Kabaddi League with any name deemed appropriate by them, with the explicit written approval from RSKA. Winning Bidder may use the RSKA Logo only for the intended purpose of naming themselves as Owners of the Mens Kabaddi League. RSKA will not lay any claim to the Intellectual property owned by the Winning Bidder at any point during or after the duration of this agreement.

The Bidder shall be solely responsible for any violation or infringement of any trademark, trade name, copyright, patent of any person, firm or company, personal right of privacy, religious beliefs and/or any other right of any other person including for adherence of regulations, administrative and judicial orders etc.

The relationship between the parties hereto shall be on a Principal to Principal basis and shall not be deemed to be a joint venture, partnership or agency of any nature whatsoever between them.

Bidder undertakes and confirms that it shall comply with all requisites, laws and regulations, necessary insurances, that are required to be complied with for conducting the event. Winning Bidder shall keep RSKA indemnified and hold RSKA harmless from any and all claims including claims for infringement, losses, demands, damages, costs, charges, expenses that may prejudice RSKA's interests and benefits, in any way whatsoever.

RSKA shall not be responsible in any way for any unfulfilled obligations and/or liabilities of Winning Bidder its Affiliates / Associations etc. and / or its agents towards any person, party, company, organization in connection with pending obligations, the finance, employment of other contractual and non- contractual.

Agreements/arrangements of whatsoever nature, whether or not in relation to the event and Winning Bidder shall continue to be solely responsible for the same

11. PENALTY CLAUSE

- 11.1 If the bidder fails to submit the 100% of the bid fee within the stipulated 7working days after signing of agreement or 15 days before the event whichever is later, a penalty of 0.25% per day will be levied on the 100% of the BID value up to a period of 7 days, if the remaining BID amount is not paid, after the expiry of 14 days beyond the stipulated period for paying the same or start of the event whichever is later the BID rights will be withdrawn as per the terms and conditions of the agreement, and amount so far paid to RSKA including EMD will be forfeited. RSKA will have right to allot it to any other one.
- 11. 2 RSKA shall be entitled to terminate this contract immediately upon a written notice, in case the Winning Bidder is in material breach and/or fail to fulfill its obligations as promised under this agreement provided Winning Bidder fails to remedy such breach within 5 days upon notification of the breach.
- 11.3 Any dispute or difference arising between Winning Bidder and RSKA shall be mutually resolved through amicable discussions failing which a sole arbitrator as mutually appointed by both the parties, arbitration proceedings would be held under the provisions of Arbitration and Conciliation Act, 1996 as amended. The procedure and fee of the Arbitrator shall be in accordance with prevailing policies and procedures of RSKA. Any dispute / differences not being the subject matter of such arbitration shall be subject to the jurisdiction of the Courts of Law at Jaipur only, as per governing laws.
